

Corenet (Pty)Ltd Terms & Conditions

1. Introduction

This Portal can be accessed at www.radiator-manufacturers.co.za (the "Portal") and is owned and operated by Corenet (Pty) Ltd ("Corenet (Pty) Ltd", "we", and "our").

These Portal Terms and Conditions ("Terms and Conditions") govern the use of the Portal.
